GIST OF THE CASE

Sri Madhab Dhurua appeared in the hearing on Dt. 10.10.2025 at the camp held at Bhikmpali under ESO Office, Panchagaon. The complainant submitted during course of hearing in brief as follows:

- 1) The complainant has raised objection regarding abnormal & average energy bills raised from February-2001 to November-2015.
- 2) To revise the EC bills as per actual meter consumption recorded.

Previous Complain, if any: Not Available

SUBMISSION OF OPPOSITE PARTY

The opposite party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4172-1301-0320, having CD-2KW under LT-Domestic, coming under ESO-Panchgaon & initial power supply effected on 01.01.1990. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

- 1) That, as per objection raised by the complainant and on examining the case in detail, the Forum observed from the available soft records (FG & Samadhan App) that average bills were raised continuously upto September-2018 billing, as no meter/meter readings were updated for billing.
- 2) A new meter bearing SL.No." LW053788" was installed on 02-Oct-2018 and actual bills continued thereafter till last billing.
- 3) It was observed from records that that average bills charged from October-2016 to September-2018 were already revised by the Opposite Party & Rs.8969.16/- was credited(withdrawn from) to the consumer's account on 28-03-2024.

ORDER

The Forum on scrutinizing the records, reports available on record construed that the Opposite Party has acted upon the grievances & revised the energy bills charged limited to two years (as per regulation 155 & regulation-157 of OERC Distribution(Condition of Supply), Code, 2019) i.e. from October-2016 to September-2018. The above bill revision carried out by the Opposite Party were found to be genuinely assessed as per regulations in force and hence, there is no further scope of revision of earlier bills.

The instant case is hereby dismissed. Accordingly, the case is disposed of.
