### GIST OF THE CASE

The Complainant filed the petition in the name Sri Jayananda Pasayat Consumer No **4172-2507-0293** under BNED, Brajarajnagar, TPWODL stated that "He was not staying in his house from July-2011 to Dec-2021. He constructed house in the same premises and came to stay his house on Jan-2022. Hence, he requests to deduct the bill for the mentioned period i.e., 07/2011 to 12/2021."

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

# SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted the ledger copy from Feb-2001 to Dec-2020 & PVR carried on 01.02.2024 and written version submitted in this case.

#### **OBSERVATION**

From complain of Complainant & from ledger statement submitted by SDO (Electrical), Belpahar it is observed that average bill has been served to consumer from Mar-2005 to Aug-2011 of 288 units per month. A meter no 8063837 was installed at consumer premises on Sepr-2011 with IMR as 0. Actual bill served from Sept-2011 to Feb-2014 with FMR 2711. Thereafter from Mrch-2014 to Feb-2017 provisional bill was served of 206 unit per months. From March 2017 to Dec 2020 bill found stopped but Rs.30267.00 charged to consumer account on Oct-2018. The outstanding arrear as on March-2017 is Rs.63869.11 but due the amount charged in Oct -2018 the outstanding arrear increases to Rs.94136.11 as on Dec-2020. The statement of the consumer is ambitious. He is telling that he was not staying in his house from July-2011 to Dec-2021 but from ledger statement it is clear that actual bill were served from Sept-2011 to Feb-2014 which is contradictory to the statement of consumer.

After repeated persuasion to the license, Forum did not get any replay for this case from 21.06.2023 to till 19.10.2023 & remain silent.
