**GIST OF THE CASE**

Sri Niranjan Sarangi, appeared in the Camp Court hearing held at Gosala, under ESO Office Gosala, on Dt. 21.11.2025. The complainant submitted during course of hearing in brief as follows:

- 1) The complainant has raised objection regarding abnormal energy bills charged previously from July-2012 to Jan/February-2014.
- 2) To revise the EC bills as per actual meter consumption recorded.

**SUBMISSION OF OPPOSITE PARTY**

The opposite party has not submitted any relevant documents in this case.

**OBSERVATION**

The case is pursued with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4118-3303-0215, having CD-3.80KW under LT-Domestic category, coming under ESO- Gosala & initial power supply effected on 01.01.1990. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

That, as per objection raised by the complainant and on examining the case in detail, the Forum observed from records that a GRF Order was passed earlier on 22.07.2022 vide CC No.- BRL/297/2022, directing the Opposite Party to revise the bills from February-2009 to Aug-2010 & from Aug-2012 to April-2014. It was learnt that the Opposite Party has already acted upon the grievances & revised the energy bills charged respectively from February-2009 to Aug-2010 with debit sundry(addition of) of Rs.1930.78/- & the provisional/average bills charged from Aug-2012 to April-2014 revised with credit sundry(deduction of) of Rs.70,507.20/-, with net credit effect of Rs.68,576.42/- adjusted on 11-01-2023.

The Forum on scrutinizing the records, reports available on record construed that the above bill revision carried out by the Opposite Party were found to be genuinely assessed as per regulations in force and hence, the complaint filed by the complainant is already resolved.

*The instant case is hereby dismissed.*

*Accordingly, the case is disposed of.*
