

In July 2025, In July-2024, I got extremely high bill due to suspected faulty meter. When I received the bill in Aug 2024, I raised a complaint and a technician visit was done from local TPWODL team. The technician checked the meter and confirmed that it is faulty but the meter was not changed immediately. On 21-Sep-2024, I raised the complaint again. The meter was changed on 21-Sep-2024, but by that time I already had higher bills for 3 months (Jul, Aug, Sep), due to faulty meter.

(4) Relief sought for.

In relief, we request the department to do bill correction and waive-off the extra-amount of ~ 2300 INR still showing in my account. Only a partial amount has been adjusted till now.
