GIST OF THE CASE

The Complainant has filed the petition in the name of Dr. Ashish Kumar Sinha bearing Consumer No **4130-0101-0760** under JED, TPWODL, Jharsuguda stated about billing dispute and issue on meter rent.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Domestic consumer having CD 10KW with initial date of p/s 22.12.2012 as seen from the FG data base/Samadhan App. The complainant has raised objection as mentioned in gist of the case. The complaint has appeared before the Forum on 09.10.2024 where the opposite party was there in Division office Jharsuguda at Camp. The opposite party has already revised the bill for the period from Nov 2023 to June 2024 w.r.t the request of the complainant & withdrawn Rs.16493.05 from the billing. The complainant was informed about the bill revision by this Forum in presence of opposite party & the complainant has convinced and accepted that the billing dispute was solved by opposite party and nothing to say by him on billing dispute. However, the complainant has raised another objection on meter rent & its recovery/chargeability.

Hence, the Forum is in the opinion that the Opposite party has already been revise the bill as per request of the complainant & hence, the grievance on billing dispute was settled but the question of recovery meter rent/chargeability/refund to be taken care by opposite party w.r.t Regulation 113 (V) of OERC Distribution (Conditions of Supply) Code,2019 to settle the grievance of the complainant.

ORDER

Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

1. The Opposite Party is directed to take action on recovery meter rent/chargeability/refund w.r.t Regulation 113 (V) of OERC Distribution (Conditions of Supply) Code,2019 to settle the grievance of the complainant & communicate to the complainant for better confirmation.
