**GIST OF THE CASE** 

The Complainant has filed the petition in the name of Kapila Nayak bearing Consumer No 4164-3201-0848 represented by Akshya Kumar Nayak under SEED, TPWODL, Sambalpur has stated about billing dispute- he has got an arrear of Rs 1,18,000/-.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

## **SUBMISSION OF OPPOSITE PARTY**

The Opposite Party has submitted consumer history for the period from May'2018 to Dec'2024 and w/s in this case.

## **OBSERVATION**

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 0.02kw with initial date of p/s 06.06.2013 as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in gist of the case. After hearing from both parties and data submitted from opposite party it is observed that:-

- 1. Arrear upto Jun'2018 = Rs 50,913/-
- 2. Arrear during Dec'2024 = Rs 1,02,692/-
- 3. Bill has been revised from Sep'2022 to Oct'2023 on meter reading basis of meter sl. no.WHL010886 for reading of 4642 kwh on 15.11.2023 and debited of Rs 7850.55/-
- 4. He does not pay electricity bill regularly and due to non-payment, the arrear has gone higher.

Hence, the instant case petition is hereby dismissed due to there is no scope for bill revision.

Accordingly, the case is disposed of.
