GIST OF THE CASE

The Complainant has filed the petition in the name of Yatra Ghatuala bearing Consumer No 4141-1354-0226 represented by Sandip Dehury under DED, TPWODL, Deogarh stated about billing dispute as well as reconnection of p/s.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted PVR & w/s dtd.18.09.2024 along with ledger copy in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-domestic consumer having CD 0.06kw with initial date of p/s 12.04.2006 as seen from the FG data base/Samadhan App. The complainant has raised objection as mentioned in the gist of the case. This Forum has given an Interim order on the date of hearing dtd. 27.8.2024 in GRF camp was held at Division Office, Deogarh instantly with the direction after taking Rs 10,000/- along with RCDC fees of Rs 177/- to reconnect the p/s immediately and to revise the bill. The opposite party has already reconnected the p/s on 28.08.2024 after receiving the mentioned amount on 27.08.2024. The complainant has been served PL/Avg. bills for the periods from Feb'2013 to Aug'2024 as seen from the FG data base. In the mean time the meter sl. no."TWSP51188129" was installed on 29.08.2024 with IMR as "o" and onward bills were served to the complainant on actual basis with reference to consumption recorded in the above meter. So, bill revision is required to settle the billing dispute.

Hence, the Forum is in the opinion that the Opposite party is liable to revise the bill of the complainant as per law considering the actual average consumption taking the of months recorded meter reading with reference to meter sl. no." TWSP51188129".

ORDER

Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

- 1. The Opposite Party is directed to revise the bill of the consumer as per law considering the actual average consumption taking the obmonths recorded meter reading with reference to meter sl. no." TWSP51188129.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier and adjust the revision as per law/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.

7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
