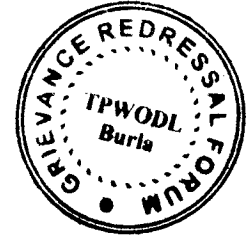




OPPOSITE PARTY
