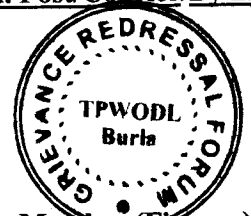

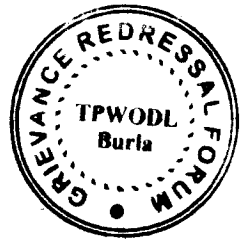


OPPOSITE PARTY
