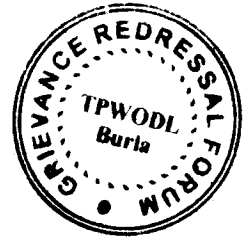


OPPOSITE PARTY
