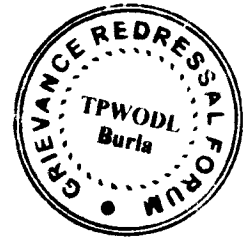


OPPOSITE PARTY
