GIST OF THE CASE

Sri Bikash Chandra Dixit appeared on Dt. 16.01.2024 at the camp held on SDO Office Ainthapali and submitted a written complaint wherein he has stated that "During the year the assessing officer alleging that there was a tempering of energy meter & debited a sum of Rs.49264.00 to his account. Then SDO Mr. Chhabra tested the old meter & found that no tempering of the energy meter & assure that the assessment amount will be deducted from his account".

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted photocopy of provisional assessment order in favor of Mr. Dixit with its calculation sheet & inspection report. The complainant Mr. Dixit submitted photocopies of application addressing to SDO, Ainthapali regarding this matter.

OBSERVATION

After careful observation on going through the relevant documents submitted by both parties, the Forum saw that it is a case of penalty so done by opposite party under section 126 of I.E. Act for which this Forum is having no jurisdiction for taking decision & issuing order. Hence the instance case petition is hereby dismissed with the direction to the opposite party to act in accordance to discussion was held during hearing where the complainant has stated about meter testing as done earlier by SDO Office & also found defective but not tempered as mentioned in the PVR for which penalty has already been lodged might be the levy of penalty was not proper followed by further verification by penalty authorities/high level committee to review the same. However, for betterment this Forum has already been talked to Ex-SDO Sri Chhabra & enquiry about the matter over phone where Sri Chhabra has admitted that the meter was tested but the test report yet to be traceable by SDO Office. In such situation, considering the matter in a linen view & taking in to confidence to Ex-SDO Sri Chhabra. The matter may be put up before high level committee formed to settle the penalty issue & take corrective action accordingly as well as steps may be taken for revision of bill as per new meter consumption following the Regulation. The complainant is also directed to approach before the Hogh level committee along with all document evidence & go for discussion to avail the benefit from them as per applicability.

Accordingly, the case is disposed of.
