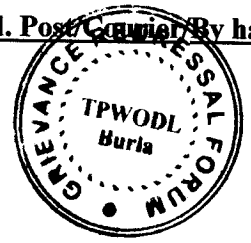

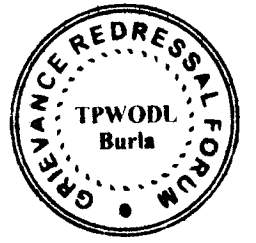


OPPOSITE PARTY
