GIST OF THE CASE

Chandra Sekhar Gadnayak has appeared on behalf of Anjali Gadnayak in the hearing on Dt. 12.09.2024 at the camp held at ESO Office, Barkote and submitted a written complaint wherein he has stated about-billing dispute- bills were served when I was not at home and I had come to home in Jan 2023. Meter was wrong since Feb 2023 which was changed by TPWODL hence, he has requested to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted billing abstract from May 2011 to July 2024, a PVR carried out on 20.09.2024 and written statement in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD of 4KW with date of initial power supply on Dt.30.05.2011 through meter Sl No 992954 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute as mentioned in GIST with prayer to revise the bill. Meanwhile, the meter with Sl No LW418873 was installed on 16.10.2019 with IMR 1 & subsequently bills were served to the complainant on Actual basis up to July 2024. Another meter bearing Sl No TWSP51198388 was also installed on 06.09.2024 with IMR '0'. The opposite party has already been revised the bill & withdrawn Rs.17838.52 from the billing as seen from Samadhan App. As observed bills were served on Actual meter reading basis & no further scope for revision of bill where also found the opposite party has already been redressed the grievance of the complainant.

Hence, the instance case petition is hereby dismissed.

Accordingly, the case is disposed of.
