GIST OF THE CASE

Sri Jogeshwar Bag bearing Con No 4131-2705-0111 appeared before this forum on dated 29th of January 2024 at its camp held in the office of ESO Office Bagdihi and submitted a written complaint wherein he has stated about billing dispute & request to revise the bill.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted consumer information sheet, a PVR carried in 05.02.2024 wherein it is found that meter Sl No is TW02082115 with CMR of 185KWh & also a written version in this case.

OBSERVATION

The case is persued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 2KW with date of initial power supply 29.06.2001 through meter Sl No 336261. The meter Sl No WCG09049 was in billing in June-July-2015 with IMR '0' & continued with CMR 14109 in July-2023 where it is seen that the billing units were 2767, 2036 in June & July 2023 respectively with PL bill of 3127 in Aug-2023. From the above billing it is the feeling of the Forum that the meter readers were not taken proper reading time to time & the opposite party has also not taken care for its verification and hence bills were raised improperly. Hence, required revision to settle the billing dispute.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from June-2015 to July-2023 by spread over the reading of 14109 units in reference to consumption recorded in meter SI No WCG09049 taking IMR as '0' & For the month of Aug-2023 taking IMR as '0' in 06.10.2023 (the date of installation of new meter) & FMR as the recorded consumption on completion of six month in reference to meter SI No TW02082115 with its daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any.

er careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

- 1. The Opposite Party is directed to revise the bill for the periods for the periods from June-2015 to July-2023 by spread over the reading of 14109 units in reference to consumption recorded in meter SI No WCG09049 taking IMR as '0' & For the month of Aug-2023 taking IMR as '0' in 06.10.2023 & FMR as the recorded consumption on completion of six month in reference to meter SI No TW02082115 with its daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.

Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.
