## **GIST OF THE CASE**

The Complainant has filed the petition in the name of Sri Trilochan Sahu bearing Consumer No 4141-1206-0085 represented by Sri Prashant Sahu under DED, TPWODL, Deogarh and stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

## SUBMISSION OF OPPOSITE PARTY

## **OBSERVATION**

The case is pursued with all documents available in record and merit of the case. On examining the case in details, the Forum observed that the complainant is a domestic consumer having CD 1kw with initial date of p/s 01.01.1990 as seen from the FG data base. The authorities of licensee have taken steps to revise the bill for the period from Nov'2022 to Oct'2023 for delay meter updating and added an amount of Rs 16,483.81/- with kwh reading "3845" on 10.11.2023 recorded in meter sl. no."300064638" installed on 28.11.2022 with IMR as "zero". The billing has been verified and found correct. There is no scope for bill revision further.

Hence, the Forum is in the opinion that as there is no scope for bill revision so the instant case petition is hereby dismissed.

Accordingly, the case is disposed of.
