GIST OF THE CASE

Sri Satyanarayan Meher on behalf of Sarpanch Huma GP appeared in the hearing on Dt. 10.02.2025 at the camp held at ESO Office, Dhama and submitted a written complaint wherein he has raised objection about wrong energy bill charged during Jan-2024 for Rs.294969.00. Hence, the complainant prayed before the Forum to resolved the billing dispute accordingly.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted a PVR carried out on 03.03.25 & written statement in this case. In reply to the case the Opposite Party submitted the following facts.

- 1. Consumer's billing was provisional basis from Aug-2017 to March-2022.
- 2. Actual bill was generated in May-2022 and provisional bill from Aug-2017 to March-2022 were adjusted.
- 3. In July-2022 provisional bill of 644 units was generated.
- 4. No bills were generated from Aug-2022 to December-2023.
- 5. In Jan-2024 a provisional bill of 18 month was generated total of 37003 units which seems abnormal.
- 6. A new Meter Sl No "TWSP51148339" was installed on Dt.27.02.2024.
- 7. From Feb-2024 to Jan-2025 billing is in actual basis.

The Opposite Party recommended that bill from July-2022 to Jan-2024 may be revised by taking new meter's actual consumption.

OBSERVATION

The case is perused with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4162-3308-0018, having CD-1.00KW under LT-General Purposes category, coming under ESO-Dhama & initial power supply effected on 01.01.1990. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

 That, regarding abnormal bill charged in Jan-2024 with an amount of Rs.294696/, the Forum observed from FG records (Licensee soft records) that, provisional bill of "37003" units was charged in Jan-2024, considering 18 months periods at a stretch that lead to charging of such abnormal bill amount. It



was pointed out that there was negative arrear balance of Rs. (-)2533.57 as opening balance as on Jan-2024.

- It was revealed that the provisional bill charged from Aug-2017 to Mar-2022 were adjusted in subsequent billing and the last previous bill was charged on provisional basis in Jan-2022 billing with "644" units, since the old meter (Meter SI No-WEP00008) was advanced upto "18712" KWh (as recorded in May-2022 billing) and remained stuck after that. There has been no trace of billing done afterwards between Aug-2022 to Dec-2023 (even though no disconnection record was found).
- 3. It was pointed out that a new Meter Sl No-"TWSP51148339" was installed in the complainant's premises on 27.02.2024. and updated in billing during Jan-2024 (replacing the old Meter No-WEP00008).
- 4. The ledger abstract indicated that actual bills have been continuing since March-2024 billing onwards, as per advanced consumption recorded in Meter SL No-"TWSP51148339". March-2024 bill was charged on actual basis with "32" units, considering the current meter reading as KWh-"000088" and initial reading was KWh-"000056"
- 5. The Opposite Party could not submit the reason for charging such abnormal bill in Jan-2024. Further, no steps taken by the Opposite Party till date to revise the erroneous bill charged.

On examining the case in detail, the Forum construed that the abnormal energy bill charged in Jan-2024 is to be revised on the basis of actual monthly average consumption recorded in meter SI No -"TWSP51148339" in order to extend fair and reasonable justice to the complainant/consumer.

ORDER

After careful consideration of hearing and documents, statements available on records, the Forum hereby passes order in consonance with Regulation of OERC Distribution (Conditions of Supply), Code,2019

- 1. The Opposite Party is directed to revise the energy bills charged in Jan-2024 on the basis of succeeding six months actual monthly average consumption as recorded in meter Sl No-"TWSP51148339" from the date/month of installation of the same, duly adjusting the bill revision made earlier and/or, the benefit arising out of the OTS Scheme, if any.
- The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the issue of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustment for the payments made by the complainant
- The Complainant is directed to pay the revised billed amount so arrived at, if any, within due date after receipt of the revised energy charges bill to which the complainant is liable to pay.

Accordingly, the case is disposed of.

The Opposite Party is directed to submit the compliance report to this Forum within one

month from the date of the issue of this order
