The Opposite Party has submitted the ledger copy for the period from Feb'2024 to Aug'2024 and meter testing report on 07.06.2024 in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Domestic consumer having CD 4kw with initial date of p/s 08.01.2024 through meter sl. no."3000082569" as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in gist of the case. The complainant has been served actual bill with reference to meter reading in the above meter. As per request of the complainant the meter has been tested on 07.06.2024 and found that the meter is ok and meter accuracy is within permissible limit. So, the billings were so served found ok and bears no merit for bill revision.

Hence, the instant case petition is hereby dismissed.
