

GIST OF THE CASE

The Complainant has filed the petition in the name of Hiralal Khenjuniwalla bearing Consumer No 4161-3412-0058 represented by Naresh Khenjuniwalla under SEED, TPWODL, Sambalpur stated about in 2005, there was an amount of Rs 13,000/- to Rs 14,000/- arrear was included in the bill due to unknown facts.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-GP consumer having CD 4kw with initial date of p/s 01.01.1990 as seen from the FG data base/Samadhan App. The complainant has raised objection as mentioned in gist of the case. During scrutiny, it came to the notice of the Forum that an amount of Rs 13,000/- was debited in billing in the month of Feb'2013 towards penalty. In this case, it is such that this Forum is having no jurisdiction on penalty issues.

Hence, this Forum *hereby dismissed this case as not maintainable with the advice to the complainant to approach either the penalty committee of TPWODL or Electrical Inspector, Sambalpur.

Accordingly, the case is disposed of.
