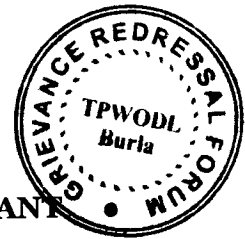

The Opposite Party has not submitted any relevant documents in this case.


OBSERVATION
