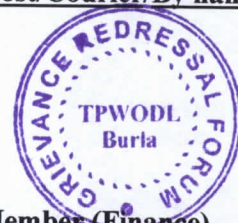

GIST OF THE CASE

Chaitanya Padhan son of the consumer Rabishankar Padhan is the complainant who appeared on Dt. 25.01.2024 at camp held on ESO Office Panchgaon under SDO Brajanaagar and submitted a written complaint wherein he has stated about Billing dispute & request to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted bill abstract of the consumer from Jan-2021 to Jan-2024 and PVR carried on 18.01.2024 received on 16.02.2024 by courier wherein it is found that meter SI No is LW374388 with CMR 12372KWh with meter status is OK with remarks given by concern authority that "suppressed reading bill may be revised for the period of Aug-2023 on the basis of actual meter reading".

OBSERVATION

The case is persued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 0.15KW with date of initial power supply 28.01.2013 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. Meanwhile, the meter SI No LW374388 was installed on 25.04.2020 with IMR '0'. The opposite party has raised the bill in Aug 2023 for KWh reading of 11343 with billing unit 9863 has happened due to improper meter reading time to time & the suppressed reading has been billed in that month hence developed the current bills for Rs.62543.34. Hence, required revision to settle the billing dispute.


Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from 25.04.2020 to 30.09.2023 (Aug-2023) by spread over the reading of 11343 units with IMR '0' in reference to consumption recorded meter SI No LW374388 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any.


ORDER


After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

1. The Opposite Party is directed to revise the bill for the periods from 25.04.2020 to 30.09.2023 (Aug-2023) by spread over the reading of 11343 units with IMR '0' in reference to consumption recorded meter SI No LW374388 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any.
2. The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
7. **Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.**

Accordingly, the case is disposed of.
