## GIST OF THE CASE

Sri Manas Ranjan Dash on behalf of Padmini Dash appeared in the hearing on Dt. 12.02.2025 at the camp held at SDO Office, Hirakud and submitted a written complaint wherein he has raised objection about high bill charged in Dec-2022 for Rs.122984.33. Hence, the complainant prayed before the Forum to revise the abnormal bill charged to resolve his grievances.

## **SUBMISSION OF OPPOSITE PARTY**

The Opposite Party could not submit any relevant document in this case.

## **OBSERVATION**

The case is perused with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4118-3406-0280, having CD-1.54KW under LT-Domestic category, coming under ESO-Hirakud & initial power supply effected on 12.10.2009. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

Abnormal bill so charged in Nov-2022 was subsequently revised extending slab benefit, for the entire period from Oct-2010 to Nov-2022, on the basis of spreading over of "21288" units from the date/month of installation of meter No-"WES40006". Hence, there is no further scope for revision of previous bills. However, the Opposite Party may allow suitable instalments facility, upon request, if any, made by the complainant.

The case is here by dismissed.

Accordingly, the case is disposed of.
