The Complainant has filed the petition in the name of Gunnama bearing Consumer No 4118-3106-0223 under SED, TPWODL, Sambalpur stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LTdomestic consumer having CD 1kw with initial date of p/s 23.10.2017 as seen from the FG data base/ Samadhan App. On scrutiny it is found that, an amount of Rs 11,630.94/- has already been credited towards bill revision for the period from May'2022 to Sep'2022 (23.06.2022 to 21.10.2022) by opposite party and found no scope for bill revision in this case. The complainant was convinced during the hearing and paid an amount Rs 5000/- on 22.10.2024 and clears the arrears.

Hence, the instant case petition is hereby dismissed.

Accordingly, the case is disposed of.
