GIST OF THE CASE

The Complainant has filed the petition in the name of Saudamini Nayak bearing Consumer No **4141-1503-0379** represented by Manoj Kumar Sing under DED, TPWODL, Deogarh stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted w/s dtd.19.11.2024, PVR dtd.23.10.2024 and ledger copy for the period from Feb'2011 to Jul'2023 in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-domestic consumer having CD 2kw with initial date of p/s 27.02.2015 with meter sl. no."992942" as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in the gist of the case. The wrong bill has been generated during Jul-Aug'2015 due to wrong punching on meter reading less than previous reading and accordingly the completion of round took place for billing unit "8364". Further, it is also seen that PL bills were served from Jul'2015 to Jun'2016. Meanwhile, meter sl. no."WUV06607" was reflected in billing in Jul-Aug'2016 which was installed on 30.06.2026 with IMR as "o". It is also seen that PL bills were served from Jun'2024 to Jul'2024 and also found that meter sl. no."TWSP51188451" was installed on 23.08.2024 with IMR as "o". So, bill revision is required to settle the billing dispute.

Hence, the Forum is in the opinion that the Opposite party is liable to recast the reading from the date of p/s to Jun'2015 taking kwh reading as "1850" with IMR as "1" with reference to consumption recorded in meter sl. no." 992942" and revise the bill for the period from Jul'2015 to Jun'2016 basing on the consumption recorded in meter sl. no." WUV06607" taking IMR as "o" in Jul-Aug'2016 and FMR as "510" kwh in May-Jun'2017 as well as for the period from Jun'2024 to Jul'2024 basing on the consumption recorded in meter sl. no. "TWSP51188451" taking 06 months consecutive consumption with the daily/monthly actual average consumption thereof with adjustment of earlier bill amount according to accounting principle and law in force.




ORDER


Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

1. The Opposite Party is directed to recast the reading from the date of p/s to Jun'2015 taking kwh reading as "1850" with IMR as "1" with reference to consumption recorded in meter sl. no. "992942" and revise the bill for the period from Jul'2015 to Jun'2016 basing on the consumption recorded in meter sl. no. "WUVO6607" taking IMR as "0" in Jul-Aug'2016 and FMR as "510" kwh in May-Jun'2017 as well as for the period from Jun'2024 to Jul'2024 basing on the consumption recorded in meter sl. no. "TWSP51188451" taking 06 months consecutive consumption with the daily/monthly actual average consumption thereof with adjustment of earlier bill amount according to accounting principle and law in force.
2. The Opposite party is directed not to consider the bill revision for the period already revised earlier and adjust the revision as per law/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act, 2003 under Section 56(i) and disconnect the power supply accordingly.
6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
7. **Opposite party is directed to submit the compliance report to this Forum within four months from the date of issue of this order as the case may be.**

Accordingly, the case is disposed of.
