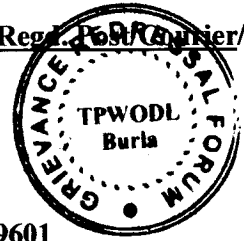

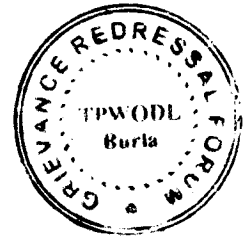

SUBMISSION OF OPPOSITE PARTY


The Opposite Party has submitted ledger copy for the period from Mar'2011 to Sep'2024 in this case.


OBSERVATION


The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-domestic consumer having CD 2.5kw with initial date of p/s 12.03.2011 as seen from the FG data base/ Samadhan App. After verification, it is seen that the opposite party has levied the penalty of Rs 8,671/- due to theft of energy which has already been transferred to FM Module in FG as seen from ledger and also found no scope of bill revision.

Hence, the instant case petition is hereby dismissed.

Accordingly, the case is disposed of.
