GIST OF THE CASE

The Complainant has filed the petition in the name of Gokula Sahu bearing Consumer No 4141-1214-1469 represented by Aintha Sahu under DED, TPWODL, Deogarh stated about billing dispute due to raising of high consumption/average bills from beginning upto Apr'2019 and from Sep'2019 to Nov'2020.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted w/s dtd.19.11.2024, PVR dtd. 14.11.2024 and ledger copy for the period from Aug'2018 to Oct'2024 in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Domestic consumer having CD 1kw with initial date of p/s 15.06.2018 with billing status disconnected but found actual billing is going on as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in the gist of the case. PL/Avg. bills were served from date of p/s to Apr'2019 as the p/s was effected without meter. The meter sl. no."LW111351" was in billing since May'2019 and installed on 17.04.2019 with IMR as "1" and continuing with actual reading upto May'2022 and bills were served with adjustment of PL bills. Further, it is seen that PL/Avg. bills were served from Jun'2022 to Jan'2024 and a new meter was in billing in Feb'2024 with meter sl. no."TWB130283".So, bill revision is required to settle the billing dispute.

Hence, the Forum is in the opinion that the Opposite party is liable to revise the bill for the period from the date of p/s to Apr'2019 considering recorded consumption in meter bearing Sl No "LW111351" taking IMR as "30"kwh in Jun'2019 and FMR as "1282"kwh in Jan'2021 and further for the period from Jun'2022 to Jan'2024 considering recorded consumption in meter bearing Sl No "TWB130283" taking IMR as "29"kwh in Apr'2024 and FMR as "563"kwh in Sep'2024 with the daily/monthly actual average consumption thereof, considering the adjustment of previous bill revisions if any as per law.

ORDER

Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

- 1. The Opposite Party is directed to revise the bill for the period from the date of p/s to Apr'2019 considering recorded consumption in meter bearing Sl No "LW111351" taking IMR as "30"kwh in Jun'2019 and FMR as "1282"kwh in Jan'2021 and further for the period from Jun'2022 to Jan'2024 considering recorded consumption in meter bearing Sl No "TWB130283" taking IMR as "29"kwh in Apr'2024 and FMR as "563"kwh in Sep'2024 with the daily/monthly actual average consumption thereof, considering the adjustment of previous bill revisions if any as per law.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier and adjust the revision as per law/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
