#### GIST OF THE CASE

The Complainant has filed the petition in the name of Madhab Behera bearing Consumer No 4141-1352-2559 under DED, TPWODL, Deogarh stated about change of category from DOM to Irrigation purpose.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

## SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted w/s dtd.20.11.2024 and ledger copy for the period from Jan'2023 to Oct'2024 in this case.

#### OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Domestic consumer having CD 1kw with initial date of p/s 20.02.2019 as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in the gist of the case. As observed the complainant has applied for the p/s for domestic category and accordingly the opposite party has released the same in favour of the complainant but the same was used by the complainant for Irrigation purpose and has happened due to wrong application by complainant to opposite party for the category. The prayer for conversion from DOM to LI category cannot be hold good as Reg.43 is not in favour of it, The last para of Reg.43 of OERC Distribution (Conditions of Supply) Code,2019 is given below for reference which is also in the w/s of opposite party:-

"Provided further, no consumer will be permitted to change the category of the service connection from any low-tension category (other than agriculture) to low-tension category for agriculture."

However, considering the prayer of the complainant the opposite party has already been released a new service connection on 28.11.2024 bearing consumer no.4141-1352-2574 in

egory LT-Irrigation pumping and Agriculture and also served the bill for the month Nov'2024 as seen from the FG data base.

Hence, the instant case petition is hereby dismissed.

Accordingly, the case is disposed of.
