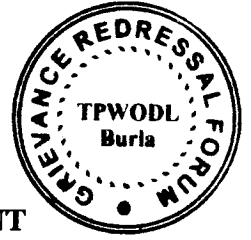


Hence the instance case petition is hereby dropped.

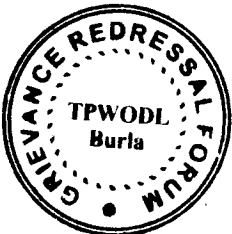
