GIST OF THE CASE

Bishnu Mirdha on behalf of Sarathi Mirdha has appeared in the hearing on Dt. 19.11.2024 at the camp held at SDO Office, Rengli and submitted a written complaint wherein he has stated that "he has applied for permanent line disconnection on his LI point but it was not done till now and provisional bill were served" & requested to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted photocopy of application address to TPWODL authority regarding permanent LD of electric connection of his LI point in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-IPA consumer having CD of 2.5KW with date of initial power supply on Dt.17.02.2016 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute as mentioned in GIST with prayer to revise the bill. The complainant has deposited of Rs.708.00 vide MR No B56378142 Dt.05.05.2022 towards disconnection fees with request to disconnect the power supply permanently on 07.03.2022 but till Oct 2024 the billing has been served to the complainant on PL/Avg basis treating a regular consumer. The opposite party is supposed to enquire the matter whether the power supply has been used since 07.03.2022 by the complainant or not and accordingly as per enquire report withdraw the billing of the periods with declaration of PDC as derived in enquiry report.

Hence it is the opinion of the Forum that the opposite party is liable to enquire the matter & withdraw the billing for non-using of electricity for the periods & declared the consumer as PDC with withdrawal of fixed cost from the date of PDC as well as adjust the security from the billing & issued NOC accordingly to the complainant.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

The Opposite Party is directed to enquire the matter & withdraw the billing for non-using of electricity
for the periods & declared the consumer as PDC with withdrawal of fixed cost from the date of PDC as
well as adjust the security from the billing & issued NOC accordingly to the complainant.
