#### **GIST OF THE CASE**

The Complainant has filed the petition in the name of Rajendra Prasad Pradhan bearing Consumer No **4140-0103-1919** under DED, TPWODL, Deogarh stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

#### **SUBMISSION OF OPPOSITE PARTY**

The Opposite Party has submitted w/s dtd.17.12.2024, PVR dtd. 11.12.2024 and ledger copy for the period from Jul'2019 to Sep'2024 in this case.

#### **OBSERVATION**

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-IPA consumer having CD 2.24kw with initial date of p/s 10.11.2018 without meter as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in the gist of the case. PL/Avg. bills were served to the complainant from the date of p/s to Dec'2022 and thereafter a new meter bearing sl. no."TPU024569" was seen in billing in Feb'2023 which was installed on 07.01.2023 and accordingly billing is continuing on PL/actual basis with adjustment of PL amount as per requirement time to time. As reported by opposite party the p/s was disconnected for non-payment of dues in Nov'2024 and reconnected in the same month after taking Rs 5000/-.The complainant has claimed that the p/s was effected through meter in the year Jan'2023 which may not be considered as true as because the complainant as paid the dues of Rs 4000/- on 11.08.2021. So, the declaration of opposite party to be considered as correct and the date of p/s to be considered as 10.11.2018.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the period from the date of p/s to Dec'2022 taking IMR as "0" kwh on 07.01.2023 & FMR as "836" kwh on 23.08.2023 with reference to consumption recorded in meter Sl No" TPU024569" with the daily/monthly actual average consumption thereof, considering the adjustment of previous bill revisions if any as periods.

### ORDER

Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

- 1. The Opposite Party is directed to revise the bill for the period from the date of p/s to Dec 2022 taking IMR as "o" kwh on 07.01.2023 & FMR as "836" kwh on 23.08.2023 with reference to consumption recorded in meter Sl No" TPU024569" with the daily/monthly actual average consumption thereof, considering the adjustment of previous bill revisions if any as per law.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier and adjust the revision as per law/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act, 2003 under Section 56(i) and disconnect the power supply accordingly.
- The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
