GIST OF THE CASE

Manoj Ku Duan representative of the consumer BibhutiBhusan Duan appeared on Dt. 25.01.2024 at camp held on ESO Office Panchgaon under SDO Brajanaagar and submitted a written complaint wherein he has stated about billing dispute & request to rectify/revise the bill.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted bill abstract of the consumer from Aug-2021 to Jan-2024 and PVR carried on 31.01.2024 received on 16.02.2024 by courier wherein it is found that meter SI No is WHL02551 with CMR 6031KWh & remarks given by concern authority that "after verification it was found that due to delayed meter updating Rs.19148.01 debited on the consumer account".

OBSERVATION

The case is persued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 0.15KW with date of initial power supply 26.12.2012 as seen from FG/Samadhan App. The complainant has raised objection on defective period billing revision with prayer to revise the bill. Meanwhile, the meter SI No LW057531 & WHL025551 were installed on 19.11.2018 & 25.10.2021 with IMR '1'& '0' respectively. The opposite party has already been revised the bill for delayed meter updating & added an amount of Rs.19148.01 as well as revise the bill for defective period assessment and added an amount of Rs.107.32 Rs.9532.85 respectively and also found that this has been done as per rule & also bills are OK. There is no Scope for bill revision. Hence, the instant case petition is hereby dismissed due to no merit.

Accordingly, the case is disposed of.
