GIST OF THE CASE

Matia Kisan has appeared in the hearing on Dt. 19.02.2025 at the camp held at ESO Office, Raghunathpali and submitted a written complaint wherein he has stated about billing dispute & the complainant has requested to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Domestic consumer having CD of 1KW with date of initial power supply on Dt.27.12.2011.

Supply has been in disconnected condition. Average/provisional bills were served from March-2017 to Oct-2020 @ 128 units/month. A new meter bearing SL No LW646600 has been replaced during Nov-2020 and actual meter reading & billing is continuing till date i.e. up to Jan-2025. During actual billing period the sixmonthly average consumption is less than the units charged previously.

ORDER

After careful consideration of hearing and documents, statements available on records, the Forum hereby passes order in consonance with Regulation of OERC Distribution (Conditions of Supply), Code, 2019

- 1. The Opposite Party is directed to revise the energy bills charged from Nov-2018 to Oct-2020 are by taking six monthly consumptions succeeding the date of meter installation as per clause No 155 of OERC Distribution (Conditions of Supply), Code, 2019, duly adjusting the bill revision made earlier and/or, the benefit arising out of the OTS Scheme, if any & instalments may be permitted for reconnection of power supply.
- 2. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the issue of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustment for the payments made by the complainant.
