GIST OF THE CASE

Achutananda Sethy has appeared in the hearing on Dt. 19.02.2025 at the camp held at ESO Office, Raghunathpali and submitted a written complaint wherein he has stated about billing dispute-high bill & excess arrear & the complainant has requested to revise/rectify the same and instal a new smart meter.

SUBMISSION OF OPPOSITE PARTY

The opposite party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Domestic consumer having CD of 1.5KW with date of initial power supply on Dt.01.01.1990.

There is average billing for more than 15 years. A new meter installed during May 2023 with meter Sl No TPWODL1061813 and monthly consumption for more then the average billing @ 550 units against 108 units/month. Bill has been revised as per OERC Regulation 155 and Rs. 53386.78 was debited in billing. There is no merit in the case, hence the instance case petition is hereby dismissed.

Accordingly, the case is disposed of.
