GIST OF THE CASE

Ghasiram Pradhan appeared on Dt. 07.03.2024 at the camp held at SDO Office, Dhanupali and submitted a written complaint wherein he has stated billing dispute-heavy outstanding of Rs.61246.00 has been seen in electricity bill since last 3 months & request to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted photocopy of application of consumer address to SDO, Dhanupali, Sundry adjustment cover sheet & Calculation sheet in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer. The complainant has raised objection on billing dispute as mentioned in GIST with prayer to revise the bill. Meter Sl No TPWODL1149167 was installed on 23.06.2023 with IMR '0' & MF 1 where it is found that the KWh reading in meter SL No WCS3530 was 3012. The opposite party has already uploaded the photo of meter & reading thereon. The KWh reading was 8016 on 24.07.2024. The above complainant was served Pl/Avg bills for the period from June 2021 to June 2023. The opposite party has already revised the bill for the period from June 2021 to May 2023 towards defective period assessment & debited Rs.59926.99 which is found correct & in accordance to law. Further, it is also seen that bill revision has also done from 23.06.2024 to 24.07.2024 & credited Rs.3806.40 in the billing of the complainant. So, found no billing dispute hence this Forum is not preferred to pass any order towards revision. During the course of hearing the complainant has prayed for consideration of instalments to clear the bill.

Hence, the instance case petition is hereby dismissed with the direction to opposite to allow suitable instalments to the complainant on application by following departmental formalities so that the complainant will able to clear the dues.

Accordingly, the case is disposed of.
