GIST OF THE CASE

Seikh Zabir Hussain has appeared in the hearing on Dt.11.12.2024 at GRF Office, TPWODL, Burla and submitted a written complaint wherein he has stated about NSC & penalty issue & requested to solve the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has not submitted any relevant documents in this case. The complainant has submitted photocopy of NSC application form, penalty assessment order & receipt of bill of 1HP motor purchased.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that both parties have appeared before this Forum on 11.12.2024. During course of hearing the complainant has admitted that the opposite party has already release the NSC on 07.12.2024 as applied w.r.t UPAN No TPW10913995. Hence, it is found that the grievance of the complainant has been resolved. In this effect the complainant has also submitted a letter to this Forum. Further, it is seen that there is penalty case lodged by opposite party on the complainant for which this Forum is having no jurisdiction. However, for settlement of penalty case the complainant is advised to approached to the authority of opposite party (penalty settlement committee of TPWODL) or the appellate authority (Electrical Inspector, Sambalpur) as per suitability of the complainant.
