GIST OF THE CASE

Durbadala Set son of the consumer Malia Set is the complainant who appeared on Dt. 25.01.2024 at camp held on ESO Office Panchgaon under SDO Brajanaagar and submitted a written complaint wherein he has stated about billing dispute & request to rectify/revise the bill.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted bill abstract of the consumer from Jan-2021 to Jan-2024 and PVR carried on 07.01.2024 received on 16.02.2024 by courier wherein it is found that meter SI No is LW154914 with CMR 12549KWh with meter status is OK with remarks given by concern authority that "suppressed reading bill may be revised for Aug-2023 on the basis of actual meter reading".

OBSERVATION

The case is persued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 0.15KW with date of initial power supply 28.01.2013 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. Meanwhile, the meter Sl No LW154914 was installed on 07.01.2020 with IMR '1'. As observed, there was supressed reading in the meter due to inefficient meter reading & having no control over the same by opposite party which was reflected in billing of Aug-2023 & hence increase the arrear with billing unit 8556 & KWh reading of 11206 as well as bill for 2292 units & 2842 units in Nov-2023 with F code but actual bill has been served in Dec-2023 (06.01.2024) for KWh reading of 12549 with billing unit 315. The opposite party has already been revised the bill for the period from Sept-2023 to Nov-2023 (30.09.2023 to 12.12.2023) and withdrawn an amount of Rs.27746.79 credited on 11.12.2023as seen from the ledger. However, required revision to settle the billing dispute.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from 07.01.2020 to 06.01.2024 by spread over the reading of 12549 units with IMR '1' in reference to consumption recorded meter Sl No LW154914 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any.

fter careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the der as follows.

- The Opposite Party is directed to revise the bill for the periods from 07.01.2020 to 06.01.2024 by spread
 over the reading of 12549 units with IMR '1' in reference to consumption recorded meter Sl No
 LW154914 with the daily/monthly actual consumption thereof considering the adjustment of previous
 bill revisions as per law if any.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.

Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.
