GIST OF THE CASE

Narendra Mahananda has appeared in the hearing on Dt. 12.12.2024 at the camp held at Division Office, Jharsuguda and submitted a written complaint wherein he has stated about acceptance of application for New Service connection.

SUBMISSION OF OPPOSITE PARTY

The opposite party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant has applied for NSC but the opposite party hold it on the ground of arrear on consumer No 4131-2308-0144 stands in the name of Purandar Bhoi as the land is relating to both. Sri Narendra Mahananda has purchased the land stands in ROR 747/1263 (Khata No) and got mutated whose ROR No 747/5720 for 04 dismi out of 26 dismil of earlier khata as mentioned. On verification it is seen that already Rs.50000.00 has been paid & credited in the mentioned consumer number & also expected Rs.60000 to Rs.70000 may be withdrawn from the billing and the outstanding reduced to Rs.65000 to Rs.70000 which to be confirm after due calculation by opposite party. As per Regulation 17(vii), the premises is liable hence without clearance NSC was not consider by opposite party but the opposite party could not confirm about the plot/premises where the existing p/s is available. As observed out of 26 dismil Sri Mahananda has purchased 04 dismil which approximately 15.40% of the total area. Sri Mahananda has paid Rs.30000.00 out of Rs.50000.00 on 16.12.2024 as per direction of this Forum and hence need not required to pay more & after revision the outstanding to be cleared by the holder of the p/s Sri Purandar Bhoi and required release of New Service Connection.

Hence it is the opinion of the Forum that the opposite party is directed to release of New Service Connection to the above complainant without asking any payment further towards outstanding dues on consumer No 4131-2308-0144 and after revision the outstanding on the above consumer to be cleared by Sri Purandar Bhoi as ordered in Case No BRL/853/2024.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

 The Opposite Party is directed to release of New Service Connection to the above complainant without asking any payment further towards outstanding dues on consumer No 4131-2308-0144 and after revision the outstanding on the above consumer to be cleared by Sri Purandar Bhoi as ordered in Case No BRL/853/2024.
