GIST OF THE CASE

Naren Padhan has appeared in the hearing on Dt. 16.12.2024 at the camp held at ESO Office, Bandhbahal and submitted a written complaint wherein he has stated about billing dispute-high meter reading without using electricity which he has inform the authority from time to time & has requested to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has not submitted any relevant documents except billing abstract from July-2003 to Nov-2024 in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-GP consumer having CD of 5KW with date of initial power supply on Dt.09.06.2023 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute as mentioned in GIST with prayer to revise the bill. It is seen that the meter SL No WVT02604 was effected in billing in Dec 2018 and given advance reading time to time as well as the complainant has been served the Actual bills but found that in Dec 2021 & Jan 2022 the billing units were 1035 & 2084 respectively which is found excess as compared to consumption pattern. But after verification it is seen that the supressed reading was billed during these months & due to which the slate benefit of tariff was missed. After due hearing & order by this Forum, the complainant has paid Rs.40000.00 on the same date. So, bill revision is required to settle the billing dispute.

Hence it is the opinion of the Forum that the opposite party is liable to spread over the reading of 9332 KWh with IMR 0 in between the periods from Dec-2018 to Jan-2024 with reference to consumption recorded in meter Sl No WVT02604 with the daily/monthly actual consumption thereof with the adjustment of previous bill revisions if any as per law.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

1. The Opposite Party is directed to spread over the reading of 9332 KWh with IMR 0 in between the periods from Dec-2018 to Jan-2024 with reference to consumption recorded in meter SI No WVT02604 with the daily/monthly actual consumption thereof with the adjustment of previous bill revisions if any as per law.

- 2. The Opposite party is directed not to consider the bill revision for the period revised earlier and adjustent the revision as per law/for the period of penalty/in both cases, if any, as applicable as it has not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the benefits of OTS scheme and rebate thereof, if any, as applicable as it has not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, serve the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived at, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
