## **GIST OF THE CASE**

Ashok Pradhan has appeared in the hearing on Dt. 16.12.2024 at the camp held at ESO Office, Bandhbahal and submitted a written complaint wherein he has requested to withdraw of penalty amount as it is charged twice.

## SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted billing abstract from March-2001 to Oct-2024, a PVR carried out on Dt.19.12.2024, Photocopy of Two No of Final Assessment order in this case.

## **OBSERVATION**

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD of 1.5KW with date of initial power supply on Dt.01.01.1990 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute as mentioned in GIST with prayer to revise the bill. During scrutiny of documents it has been observed that the opposite party has served the Provisional Assessment on 02.02.2017 & also served the final assessment order on 18.02.2017 for Rs.20520.00 which was debit in billing in the billing month Aug-Sep-2017 as well as also debited in Oct-Nov-2017 for the same amount I,e, Debit the above amount twice in billing. The Forum saw that the enforcement settlement committee has already settle the penalty amount for Rs.10260.00 & accordingly the complainant has paid the same on 29.08.2022 as seen from the FG data base & also saw that Rs.10260.00 has already ben credited on 17.02.2023 in ledger in FG. From the above it is confirm that there were two entries for penalty mount for Rs.20520.00 each debit out of which ne penalty amount has already settled on payment & credit in ledger but another is still pending for withdrawal from the billing and in this regards directions was given by this Forum to opposite party to do the same but did not taken care which to be treated as lapses lying with opposite party which creates dissatisfaction of consumer,& harassment also. Why the order during hearing has not been carried out by opposite party need to be explained along with compliance.

Hence it is the opinion of the Forum that the opposite party is liable to withdraw the penalty of Rs.20520.00 from billing as it is debited twice after due further verification of documents by opposite party-SDO, Belpahar DM (F&C) and EE, BNED, Brajarajnagar, TPWODL and given effect in billing accordingly.

#### **ORDER**

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

- 1. The Opposite Party is directed to withdraw the penalty of Rs.20520.00 from billing as it is debited twice after due further verification of documents by opposite party-SDO, Belpahar DM (F&C) and EE, BNED, Brajarajnagar, TPWODL and given effect in billing accordingly.
- The Opposite party is directed not to consider the bill revision for the period already where the complainant 2. has availed the benefits of OTS scheme and rebate thereof, if any, as applicable as it has not submitted any information for the same.
- Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
