GIST OF THE CASE

Kame Kisan has appeared in the hearing on Dt. 18.12.2024 at the camp held at Jharagogua under ESO Office, Tileibaniand submitted a written complaint wherein he has stated about billing dispute- abnormal meter reading & billing for Rs.40000.00 in a single month & has requested to revise/rectify the bill.

SUBMISSION OF OPPOSITE PARTY

The opposite party has not submitted any relevant documents except billing abstract from Feb-2011 to Oct-2024 in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD of 0.11KW with date of initial power supply on Dt.15.12.2010 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute as mentioned in GIST with prayer to revise the bill. Bills were raised on KTJ tariff up to July-2016 except bills of Jan-2012, July-2012, Nov-2013 & July-2014 as Domestic category has happened due to table reading and hence to be treated as improper reading & billing. So, the billing up to July-2016 to be treated as KTJ category. In Sept-2016 reverse reading has been punched hence, round competition of meter took place & billed for 9672 units was absolutely incorrect & the billing was also incorrect. Since April-2017 Avg bills were served up to Oct-2019 & there after a meter SL No LW318050 was in billing in Sept-Oct-2019 but the billings were so raised not in accordance to meter reading on monthly basis & found that since Dec-2020 to Oct-2024 the consumptions units were less than 30 units which coming under KTJ category. During course of hearing the complainant has stated that he is having only two numbers of bulb in that premise for use where the opposite party was there & also admitted about the material facts & agreed that the pattern of consumption of the above complainant is very low. Considering all the material facts & billing data base as well as hearing of both parties it is concluded that the above complainant is using the p/s less than 30 units since date of power supply and hence to be treated as KTJ category.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill from the date of power supply to Dec-2024 treating the tariff as KTJ to settle the billing dispute with the adjustment of previous bill revisions if any as per law.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

- 1. The Opposite Party is directed to revise the bill from the date of power supply to Dec-2024 treating the tariff as KTJ to settle the billing dispute with the adjustment of previous bill revisions if any as per law.
- 2. The Opposite party is directed not to consider the bill revision for the period revised earlier and adjust the revision as per law/for the period of penalty/in both cases, if any, as applicable as it has not submitted any information for the same.
- The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the benefits of OTS scheme and rebate thereof, if any, as applicable as it has not submitted any 3.
- The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment
- The Opposite Party is directed to collect the revised bill amount and on non-payment, serve the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and 5. disconnect the power supply accordingly.
- The Complainant is directed to pay the revised billed amount so arrived at, if any, within due date after 6. receipt of the revised energy charges bill to avoid disconnection.
- Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
