GIST OF THE CASE

Hagru Behera on behalf of Usha Behera has appeared in the hearing on Dt. 19.12.2024 at the camp held at Division Office, DED, Deogarh and submitted a written complaint wherein he has stated about billing dispute & has requested to revise/rectify the bill.

SUBMISSION OF OPPOSITE PARTY

The opposite party has not submitted any relevant documents except billing abstract from Feb-2021 to Nov-2024 in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD of 0.25KW with date of initial power supply on Dt.20.12.2018 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute as mentioned in GIST with prayer to revise the bill. The prayer of the complainant in the application may be referred by opposite party as enclosed & conduct enquiry about active of p/s and month as well as year (period of active). The meter SL No TW02013341 was in billing since April-2022 & found that except few months the consumption pattern was less than 30 units belongs to KTJ category.

Hence it is the opinion of the Forum that the opposite party is liable to conduct an enquiry headed by EE, DED consisting of SDO, ESO, AOC/AOT and a lineman in presence of the complainant and accordingly take appropriate steps as per outcome of the report to settle the grievance of the complainant as well as may convert the category to KTJ if found as peer enquiry and if applicable as per law.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

 The Opposite Party is directed to conduct an enquiry headed by EE, DED consisting of SDO, ESO, AOC/AOT and a lineman in presence of the complainant and accordingly take appropriate steps as per outcome of the report to settle the grievance of the complainant as well as may convert the category to KTJ if found as peer enquiry and if applicable as per law.

- The Opposite party is directed not to consider the bill revision for the period revised earlier and adjust the revision as per law/for the period of penalty/in both cases, if any, as applicable as it has not submitted any information for the same.
- The Opposite party is directed not to consider the bill revision for the period already where the complainant 3. has availed the benefits of OTS scheme and rebate thereof, if any, as applicable as it has not submitted any information for the same.
- The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days 4. from the receipt of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- The Opposite Party is directed to collect the revised bill amount and on non-payment, serve the Disconnection Notice to the Complainant as per Indian Electricity Act, 2003 under Section 56(i) and disconnect the power supply accordingly.
- The Complainant is directed to pay the revised billed amount so arrived at, if any, within due date after 6. receipt of the revised energy charges bill to avoid disconnection.
- Opposite party is directed to submit the compliance report to this Forum within one month from the date of 7. issue of this order as the case may be.

Accordingly, the case is disposed of.
