SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted consumer history from Aug-2018 to Jan-2025 in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Domestic consumer having CD of 0.05KW with date of initial power supply on Dt.11.05.2018.

It is found that bill is OK, there is no scope of revision, hence the instance case petition is hereby dismissed as defective meter assessment of Rs.8440.22 has been added in Jan-2025 billing for the period from July-2021 to May-2023.

Accordingly, the case is disposed of.
