GIST OF THE CASE

Dilip Ku Naik has appeared in the hearing on Dt. 20.12.2024 at the camp held at ESO Office, Laikera and submitted a written complaint wherein he has stated about billing dispute-High billing in May-2023 for Rs.37400.00 which is wrong according to him & has request to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD of 1.5KW with date of initial power supply on Dt.01.01.1990 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute as mentioned in GIST with prayer to revise the bill. The opposite party has debited Rs.29267.00 towards defective period assessment for the period from Oct-2019 to Sept-2021 & served the actual bill including current bill for Rs.37400.94 in the month of March-2023. The meter SL No WHL033126 was effected in billing in Oct-2021. The IMR in Nov-2021 was '0' & assume might be installed on last date of the Oct-2021 month. After verification it is concluded that the bills were OK and the opposite has debited the amount as per law although PL/Avg bills were served more than two years but bill revision done for two years leaving others periods where the complainant given the benefit as because high consumption has been seen after replacement of the meter.

Hence it is the opinion of the Forum that there is no scope for bill revision & the opposite party has done the bill revision correctly & hence, the case is here by dismissed.

Accordingly, the case is disposed of.
