GIST OF THE CASE

The Complainant has filed the petition in the name of Sunil Sahu bearing Consumer No 4170-0103-3554 represented by Nalini Sahu under BNED, TPWODL, Brajrajnagar has stated about billing dispute – Previously bill was billed for Rs 252/month approximately. But, since nearly 02yrs bill has been served for Rs 10,000/-/month and arrear becomes Rs 31,063/-.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted consumer history for the period from Jun'2019 to Jan'2025 and PVR dtd.22.02.2025 with KWH reading 18783 and meter status ok in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Irrigation and pumping and Agriculture consumer having CD 3hp with initial date of p/s 28.04.2019 as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in gist of the case. After hearing from both parties, it is observed that there is provisional billing upto Mar'2022 on the basis of without meter. The meter with sl. no."TPU019097" was installed during Mar'2022(10.03.2022) as known from FG. After installation of meter the actual consumption has been recorded and bill has been raised accordingly. So, there is no merit in the case.

Hence, the instant case petition is hereby dismissed. Accordingly, the case is disposed of.
