GIST OF THE CASE

Charan Kisan has appeared in the hearing on Dt. 20.02.2025 at the camp held at SDO Office, Belpahar and submitted a written complaint wherein he has requested to revise the wrong bill & allow instalments.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted consumer history from March-2001 to Nov-2024 in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Domestic consumer having CD of 2KW with date of initial power supply on Dt.01.0 .1990. It is found that from Nov-2012 to Nov-2018Provisional/Average bills with 288,216 etc were served on bimonthly basis. In Jan 2019, a new meter Sl No LW077803 was installed. The IMR was 138 on 13.02.2019 & 1363 as on 14.08.2019. So, 1225 units consumed in six months & the average consumption is 204 units/month.,

So, the consumption is same in the old & new meter. So, the bill is correct. There is no scope for revision & hence the instance case petition is hereby dismissed. The complainant has requested for instalments which may be allowed as per rule.

Accordingly, the case is disposed of.
