## GIST OF THE CASE

The Complainant has filed the petition in the name of Sri Nabin Padhan bearing Consumer No 4131-2701-1081 under JED, TPWODL, Jharsuguda stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider his case for revision/rectification.

# SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted the PVR dtd. 05.02.2024 and w/s in this case.

### **OBSERVATION**

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a domestic consumer having CD 1kw with date of initial power supply 01.03.2010 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. The meter sl. no. "LW586438" was installed on 29.03.2021 with IMR "zero" & MF "1". The above complainant has already been served PL/Avg. bills for the period from Oct-Nov'2015 to Feb'2021 @ 50/25 units monthly/bi-monthly which seems to be very small units of consumption as compared to other periods. In the meantime, the opposite party has revised the bill for defective period for the period from Mar'2019 to Feb'2021 and debited an amount of Rs 4039.02/- in the billing and done with reference to regulation 155 of OERC(Conditions of Supply) Code,2019. However, for verification of correctness to be recalculated further.

Hence it is the opinion of the Forum that the opposite party is liable to verify the calculation so done for the period from Mar'2019 to Feb'2021 in reference to consumption recorded in the meter sl no."LW586438" taking IMR as "1" kwh on 29.03.2021 and FMR as "408" kwh on 27.10.2021 and the daily/monthly actual consumption thereof with adjustment of revisions and amount already done and accordingly effect difference in the billing as per accounting principle.

#### **ORDER**

Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

1. The Opposite Party is directed to verify the calculation so done for the period from Mar'2019 to Feb'2021 in reference to consumption recorded in the meter sl no." LW568438" taking IMR as "1" kwh on 29.03.2021 and FMR as "408" kwh on 27.10.2021 and the daily/monthly actual consumption thereof with adjustment of revisions and amount already done and accordingly effect difference in the billing as per accounting principle.

- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier and adjust the revision as per law/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.

Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
