The Complainant has filed the petition in the name of Sri Bihari Deep bearing Consumer No 4118-3410-0024 under SED, TPWODL, Sambalpur stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider his case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records and merit of the case. On examining the case in details, the Forum observed that the complainant has raised objection for NSC allowed to his younger brother with a separate supply. As per regulation is concerned, the younger brother is entitled for getting NSC in its name and the elder brother should not raised objection for the same and if objected will not hold good. In present case the opposite party has released the NSC to younger brother of the complainant with reference to direction has already been given vide GRF case No.597 of 2023 dtd. 30.12.2023.

Hence, the Forum is in the opinion that the Opposite party has taken the decision to provide the NSC to younger brother of the complainant with reference to regulation so the instant case petition is hereby dismissed.
