GIST OF THE CASE

Sri Ashwini Ku Rout appeared before this forum on dated 29.01.2024 at its camp held in the ESO Office, Bagdihi under SDO-I Jharsuguda and submitted a written complaint wherein he has stated about billing dispute & he has requested to revise the bill.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted billing abstract from Sept-2020 to Dec-2023, a PVR carried on 05.02.2024 wherein it is mentioned that the Meter SL No WLT069130 with CMR 7293Khw & remarks given by the authority that "as per physical verification & internal analysis the provisional period amount has been adjusted so the bill revision may not be possible"

OBSERVATION

The case is persued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 1KW with date of initial power supply 30.03.2018 through meter Sl No WLT069130 as seen from FG/Samadhan App & also continuing till date. The complainant has raised objection on billing dispute with prayer to revise the bill for the period from May-2018 to Dec-2020. During verification of the ledger, it is seen that PL bills were served to the complainant for the periods has already been adjusted on issue of actual bills time to time accordingly. This Forum has gone through the PVR as well as W/S of opposite party where they clearly mentioned that provisional bills were already adjusted & found billing of the consumer is OK so there is no scope for bill revision.

Hence the instant case petition is hereby dismissed.


