ORDER

Brief Facts of the Case

During the spot hearing at Rajgangpur-II Electrical Sub-division of Rajgangpur Electrical Division camp on 23-02-2024, the complainant appeared before the Forum whereas SDO- Rajgangpur-II appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT- Domestic consumer having consumer No. 813414100096 with connected load of 0.11 KW. That the Complainant has raised objection regarding the high consumption bills served to him. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

1. Submission of the Complainant:

- The complainant submits that, high consumption bills have been served to him due to which high billings have been done resulted to accumulation of arrear.
- He further submits that; he had made verbal complain to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

2. Reply Submission of the Respondent:

- The respondent produced the billing abstract from Nov'2011 to Jul'2023 and a PVR dated 06-02-2024 mentioning the meter reading as "55" KWH of meter no. 300033308.
- The respondent also agreed to the high consumption billing in May'2019 and agreed for revision of bills. However, the respondent requested the Forum to take appropriate decision as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- That the complainant has been billed on actual meter readings up to Jan'2019 with a meter reading of "1927" of meter no. 611946. It is noted from the ledger that from Feb'2017 no proper readings have been taken and in the month of May'2019 bills have been served @1936 units with a meter reading of "1939" by taking the wrong IMR as "0003".
- Therefore, it is decided by the Forum that, wrong bills should be revised.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The provisional/average/wrong bills served to the complainant from Feb'2019 to May'2019 are to be revised by taking the IMR as "1927" and FMR as "1939" as per Section 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments done during the revision period are also to be taken in to consideration.
- DPS charged on the wrong bills are also to be withdrawn.

Matter is closed herewith and the compliance report to be submitted to the undersigned on or before dated **31-03-2024**.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
