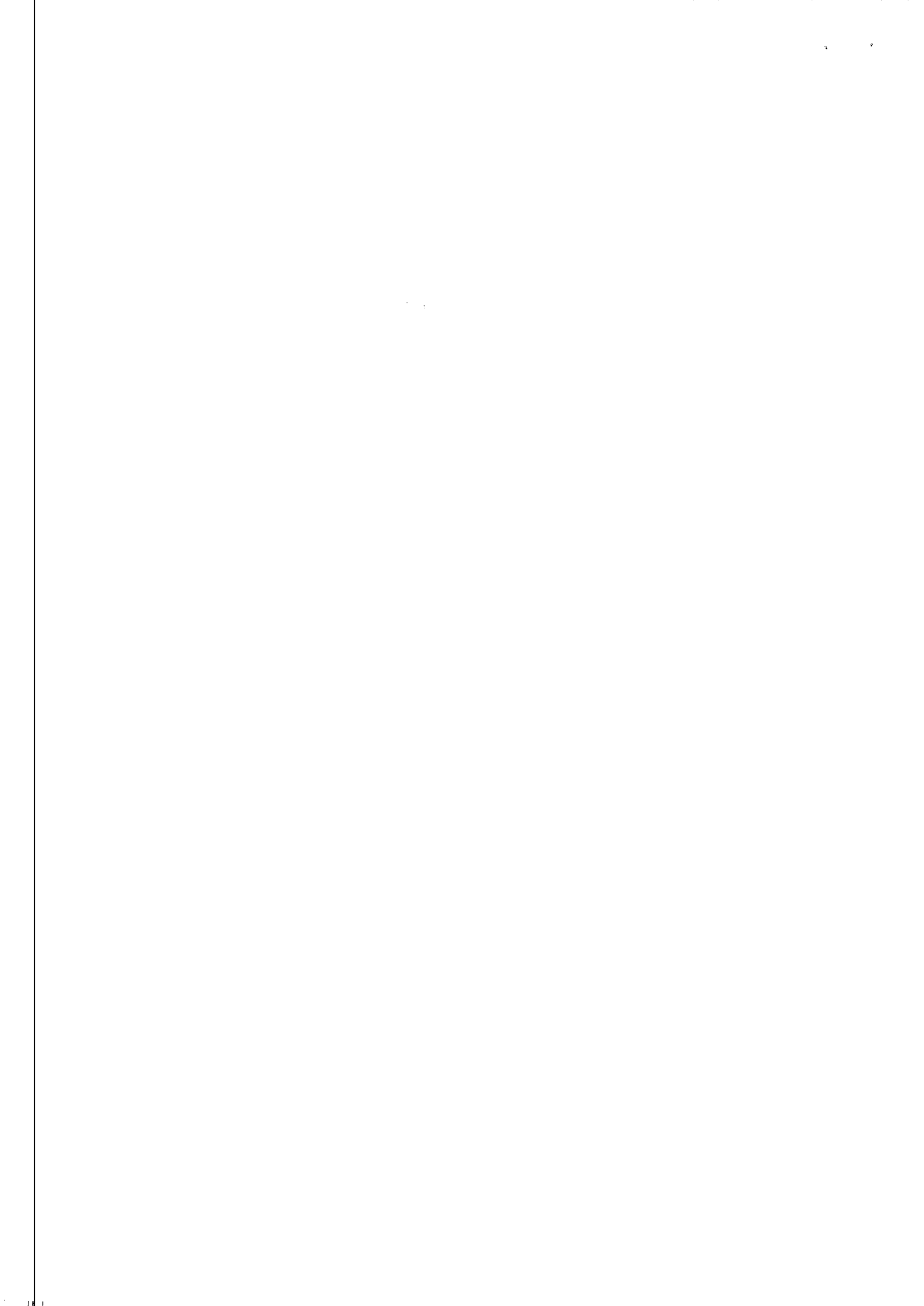

- That the complainant has been billed on actual meter readings up to Dec'2009 with a meter reading of "2455" of meter no. A1819347. From Jan'2010 to Jan'2017, provisional/average bills have been served @ of 50 units, 100 units, 164 units etc. due to defective meter.
- In the meanwhile, a new meter bearing Sl. No. WUV24511 has been installed in Feb-Mar'2017 in the premises of the complainant.
- Therefore, it is decided by the Forum that, the average period bills should be revised.

### **Directions of the forum**

In view of the above findings and discussions, the Forum is of the view that,

- The provisional/average bills served to the complainant from Feb'2015 to Jan'2017(Two Years) are to be revised as per the average of six consecutive billing of new meter as per Section 155 and 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments done during the revision period are also to be taken in to consideration.
- DPS charged on the wrong bills are also to be withdrawn.

Matter is closed herewith and the compliance report to be submitted to the undersigned on or before dated **31-05-2024**.
